## MANAGEMENT AGREEMENT FOR STATE CAPITAL IMPROVEMENT PROGRAM FACILITIES

This Agreement is made and entered to at BOARDMAN, Ohio this Z day of NORDMAN, Ohio this Z day of NORDMAN, 2016, by and between the ABC Water District Board of Commissioners (hereinafter referred to as the "ABC") and Aqua Ohio, Inc., a public utility providing water service in areas of Mahoning County, Ohio, through its Struthers Division (hereinafter referred to as "Aqua").

#### **PREAMBLE**

WHEREAS, Aqua is furnishing public water service and water for public fire protection to certain areas of Mahoning County, and

WHEREAS, the ABC by utilizing funding under Ohio Facilities Construction Commission ("OFCC") is constructing water distribution facilities in the subject area and desires that Aqua provide water to be served through these facilities, which will include approximately 820 feet of 8" inch waterline and necessary appurtenances including three gate valves and two fire hydrants, as shown in Exhibit "A" (2 pages), such facilities to be constructed on Raupp Road in Boardman Township, Mahoning County, Ohio.

NOW, THEREFORE, the parties agree as follows:

#### **ABCs OBLIGATIONS**

- 1. Construction. The ABC will construct water distribution facilities funded by OFCC which are substantially described on Exhibit A attached hereto (hereinafter "Facilities").
- 2. Plans and Specifications. Plans and specifications for Facilities to be constructed shall be in accordance with all applicable regulations and engineering standards, with the Facilities to be compatible with any interconnecting systems.
- 3. Ownership. The water distribution Facilities constructed by the ABC as part of the subject OFCC project shall be owned by the ABC.
- 4. Service by Company. The ABC agrees to allow Aqua to provide water service to customers through these Facilities in the manner and subject to terms set forth in this Agreement. It is further understood that during the term of this Agreement, it may become

necessary to transmit water through the Facilities to portions of Aqua's system serving Company customers other than those directly connected to the Facilities.

The ABC acknowledges that the terms of this Agreement may vary from Aqua's standard operating rules and regulations in effect in Aqua's service area within Mahoning County in the following respects:

- (a) Aqua will not own the subject Facilities.
- (b) Aqua will provide maintenance, repairs and replacements of the Facilities owned by the ABC; provided, however, the ABC, as owner and beneficiary of any warranties or bonds on the Facilities, shall be responsible for costs of any repairs or replacements during the period of one (1) year subsequent to the date the Facilities are placed in service.
- (c) Aqua will not collect any front footage charges or other charges related to the Facilities (other than Aqua's related facilities fee and customer impact fee, determined in accordance with Aqua's Tariff and/or local rate agreement, as amended from time-to-time), or pay any refunds to property owners.

## **COMPANY OBLIGATIONS**

# 5. Management of Facilities.

- (a) Upon completion of construction, the ABC will certify to Aqua that:
  - (i) The Facilities just completed have been constructed in accordance with approved plans and specifications earlier for the Facilities;
  - (ii) That the Facilities have been chlorinated and pressure tested according to standards set forth in specifications and as required by applicable laws and regulations;
  - (iii) That all necessary fees, charges for labor and materials and other construction costs have been paid in full.
- (b) Upon such certification, Aqua shall thenceforth accept responsibility of all maintenance and associated costs of the Facilities in accordance with Paragraph 8 hereof, except that the ABC shall be responsible for costs of any repairs or replacements during the period of one (1) year subsequent to the date the Facilities are placed in service for which any warranties or bonds on the Facilities are applicable, beginning when service begins and/or water is transmitted to customers through the Facilities, and Aqua shall thereafter furnish water

service to customers using the Facilities as customers of Aqua under the terms and conditions set forth herein.

- (c) Aqua shall manage and operate on a day-to-day basis the Facilities, including maintenance of said Facilities as set forth in Paragraph 8 and all testing of the water supply mandated by the EPA, and Aqua shall be responsible for all associated utilities, supplies and power sources for the Facilities.
- 6. Consideration. As consideration to Aqua for water service and management of the Facilities, Aqua shall bill and charge customers who tap into the Facilities for water service. Such charges for service shall be the same as per unit and itemized rates and charges set forth in Aqua's then current rules and regulations applicable to Aqua's customers in its Struthers Division, which are subject to the review and approval of the Public Utilities Commission of Ohio, or review and approval by the Board of Commissioners of Mahoning County, Ohio. ABC acknowledges that future changes to Aqua's charges for service are accepted by ABC when approved by either of the aforementioned public entities.

#### MUTUAL OBLIGATIONS

- 7. Term. The term of this Agreement shall be for the actual life of the Facilities, or the longest term allowed by law if shorter. The ABC shall have the right to terminate this Agreement without penalty or cause.
  - (a) In the event this Agreement terminates and Aqua is required to continue water service to customers served by these Facilities by reason of relevant statutes, rules, and regulations including, but not limited to Public Utility Commission of Ohio requirements, then Aqua shall be permitted to continue charging for such service in the manner described in this Agreement.
  - (b) In the event this Agreement terminates, and other portions of Aqua's system are supplied in full or part by water transmitted through these Facilities, and Aqua is required to continue providing service in such other portions of Aqua's system in accordance with its obligations as a public utility, such transmission may thereafter continue upon payment by Aqua

to the ABC of a transmission fee of ten cents (\$.10) per thousand gallons of water so transmitted through the Facilities. Said price may be adjusted by the ABC by a percentage equal to one half of the percentage by which rates for residential customers within the service area served by the Facilities are adjusted between the date this Agreement takes effect and the date such transmission fee is first payable, with similar ratable adjustments to also be applicable thereafter.

- (c) Aqua agrees that such transmission shall not negatively affect water service and pressures for customers served by the Facilities.
- 8. Maintenance, Repairs and Replacement. Aqua will provide, at its cost, maintenance and repairs (except for the one year period as set forth in Paragraph 4(b) hereinabove), including main break repair and necessary replacements to the Facilities.
  - (a) Aqua shall give the ABC reasonable prior notification of proposed replacements, including estimated costs to be incurred. Unless there is an emergency threatening continuity of service and/or public health and safety, the ABC's prior written consent shall be obtained for replacements. The ABC agrees that consent shall be promptly given or the ABC shall promptly provide the necessary replacements.
  - (b) Facilities replaced by Aqua ("Replacement Facilities") shall be owned by Aqua. Upon any termination of this Agreement, the ABC shall purchase any such Replaced Facilities from Aqua at its replacement cost new less depreciation, determined as of the date of such purchase. Aqua shall provide satisfactory evidence to the ABC for the cost of any Replacement Facilities. Aqua shall have the same rights to the Replacement Facilities as if they were the Facilities pursuant to this Agreement.
  - (c) Aqua shall not be responsible for any costs of relocation of the Facilities required by any party other than Aqua.
  - (d) Aqua shall have the right to connect into and/or extend from the Facilities or any portion of Aqua's system served by the Facilities to provide water

service and no such connection of extension shall be considered part of the Facilities.

- 9. Liability. Aqua shall not be liable for any claims arising from or pertaining to the initial construction, design materials or workmanship of the Facilities (other than as arises from Aqua's own action) and the ABC agrees to indemnify, protect and hold harmless Aqua from such claims. Aqua shall be subject to all requirements and responsibilities to customers and all standards for service as set forth in its tariff, rules and regulations except as set forth in this Agreement and Aqua shall hold the ABC harmless from any claims arising against it based upon Aqua's negligence.
- 10. Regulatory Measures and Standards. This Agreement and the parties' obligations thereunder are subject to Aqua's Tariff other than as set forth hereinabove, and any necessary review and approval by the Public Utilities Commission of Ohio and any other applicable regulatory body. All provisions herein shall comply with and be in conformance with the Ohio Facilities Construction Commission Project Grant Agreement by and between Boardman Township and the Ohio Facilities Construction Commission, pursuant to which the OFCC funds were made available for construction of the Facilities. All provisions herein shall also comply with and be in conformance with an agreement by and between Boardman Township and the ABC, transferring ownership of all Facilities to the ABC.
- 11. Easement for looping the Facilities. The ABC agrees to give Aqua a 20-ft wide easement as shown on Exhibit "B". The easement shall only be used for looping additional water main to the Facilities as shown in Exhibit "C".
